#### Slower traffic on A588

Gina is supporting both local Parish Councils' calls for further speed limits in the vicinity of Cockerham and Upper Thurnham village centre.

Highways Officers have sadly repeated that the A588 does not meet the national criteria for the introduction of further speed limits.

Gina said: "My hope is that the 'average speed camera road safety scheme for the A588', currently in the final stages before introduction, will provide some safety benefit within the villages along the route."

'SLOW' road markings have finally been replaced on Moss Lane – and Highways have promised an advisory 30mph sign in the easterly direction.

# Floating Pontoons for Glasson basin marina

Gina wrote to the City Council planning officers expressing concerns about the possible disturbance to the bed of the basin by the proposed replacement of the existing 10 pontoons with floating pontoons.

The RSPB and Thurnham with Glasson PC both submitted responses highlighting the dangers of contamination. However Natural England, in their response about the effect on marine ecology, stated that they do not believe there will be an adverse effect.

Planners say that while piling will cause some disturbance to mud, it would not cause significant harm to the site. The deadline for comments is closed and the planning application is due to be decided imminently.

## **Gina for re-election to County Council**

#### **Bailrigg Garden Village (or new town?)**

The master-planning stage for Bailrigg Garden Village has now ended. More than 8000 new homes are planned - way above the figures quoted previously. They would be built over the next 20-25 years on the fields either side of Lancaster canal, stretching to Galgate and Conder Green. There will be a consultation on the next stage - the 'Lancaster South Area Action Plan'.

Gina says: "If it were to proceed as planned, this 'new town' will be the biggest change to Lancaster for decades. It is important that the ideas and concerns of local people are properly respected. Green councillors have serious concerns about how the necessary infrastructure will be financed. We don't want to end up with piecemeal development."

#### 'Bay Council' proposal

'The Bay' Unitary Authority, which would include the districts of Lancaster, South Lakeland and Barrow, is now one of four proposals in a Government consultation on the creation of new councils.

It would replace the existing twotier system with a single council responsible for providing all local government services.

## **Glasson Dock: village changes update**

Gina attended an online meeting between members of Thurnham Parish Council and the Lancaster Port Commission (LPC) in March to discuss the recent changes by LPC which have affected some residents in the village.

Gina said: "I was pleased to be able to meet members of the Port Commission and to emphasise the importance of engaging with the local community about their plans. The Port plays a very important role in Glasson village life. Despite some clear differences of opinion about changes made to date, the meeting was respectful and I am hopeful that there will be a constructive approach in the future."

Issues and ideas put forward included:

- · Port Commissioners attending Parish Council meetings;
- An open community meeting at which LPC presents its plans and answers questions;
- A written explanation from LPC for its earlier actions, delivered to local residents as part of a regular newsletter.

LPC members agreed to discuss these ideas with their full board, and communicate with the Parish Council as soon as this could be arranged.
